



Alamo 取車提醒事項

一、汽油費用: 有下列 3 種方式:

- (1). 『滿油取車，滿油還車』。
- (2). 『滿油取車，不加滿油還車』，您用多少付多少給 Alamo。
- (3). 向 Alamo 購買第一缸油，還車時可把油用完，若未用完無法退費。

二、駕駛人(含第二駕駛人)均須年滿 25 歲以上。取車前請務必備妥: (1). 有效期限一年以上的台灣駕照與國際駕照、(2). 信用卡(Debit Card 不接受)、(3). 中華民國護照、(4). 租車確認單或確認號碼(Confirmation Number)。以上證件缺一不可。

請注意: (1). 您的租車費用限中華民國護照持有者使用，切勿用美國及加拿大駕照取車。
(2). 21-24 歲駕駛人有年輕駕駛附加費，每日約 25 美金 (依各州各有不同)。

三、取車時如現場辦理車型升級、臨時增加自購選項(如安全座椅、保險)、更改還車時間、地點等等而導致與您原來費率有所不同時，請務必確認金額，方才簽署『租賃合約』(Rental Agreement，簡稱 RA)。Rental Agreement 範本如後頁所示供您參考。取車前請詳閱之。如有任何異議，請將取車點該名人員姓名、聯絡 Email 記錄下來，以利後續追查之用。

四、還車前請務必檢查您的、行李、財務是否都已拿下車。尤其是像:皮夾、太陽眼鏡、水壺等這類小物件是最容易被忽略的。

五、發生意外處理方法(案件發生 24 小時內完成)

- ✧ 通知警察(911)及 Alamo 告知意外發生
- ✧ 撥打 Alamo 的道路救援專線: 美國 1-800-803-4444/加拿大 1-800-407-4411
- ✧ 記下負責該事件之警察人員姓名及部門
- ✧ 對方車輛駕駛姓名、地址、駕照號碼, 保險公司和保險號碼
- ✧ 請保存警員給您的事故紀錄副本，交給 Alamo 處理後續保險事宜。

六、如需更改或取消，請於取車前 48 小時前通知。如遇假日請提前作業。
